The JJAB’s/SEJAY is responsible for addressing DMC through processes outlined in the OJJDP-DMC reduction model and for making recommendations to the State regarding best practices and systemic changes to address DMC.

The JJAB’s/SEJAY are in pursuit of services for research and analysis on two current DMC projects:

- 1) A new State DMC assessment which has been mandated by the OJJDP for all states (DMC Plan: Goal 2, Objective A). This will require qualitative and quantitative research.
- 2) The JDRAI study is an elective project which is an expanded study on a previously piloted project for a recommended Detention Risk Assessment Instrument. (DMC Plan: Goal 2, Objective B).
